The academic staff of the institution (including part time staff) is paid salary in such scale of pay as prescribed by the UGC/University/Affiliating Body from time to time through account payee cheque or as per advice into the bank account of employee specially opened for the purpose. The supporting staff shall be paid as per the UGC/State Government/Central Government pay scale structure.
- iii. The management of the institution shall discharge the statutory duties relating to pension, gratuity, provident fund, etc. for its employees. The institution shall follow all the norms of the NCTE as amended from time to time.
- iv. The reservation for SC/ST/OBC and other categories have been followed as per Government norms.
